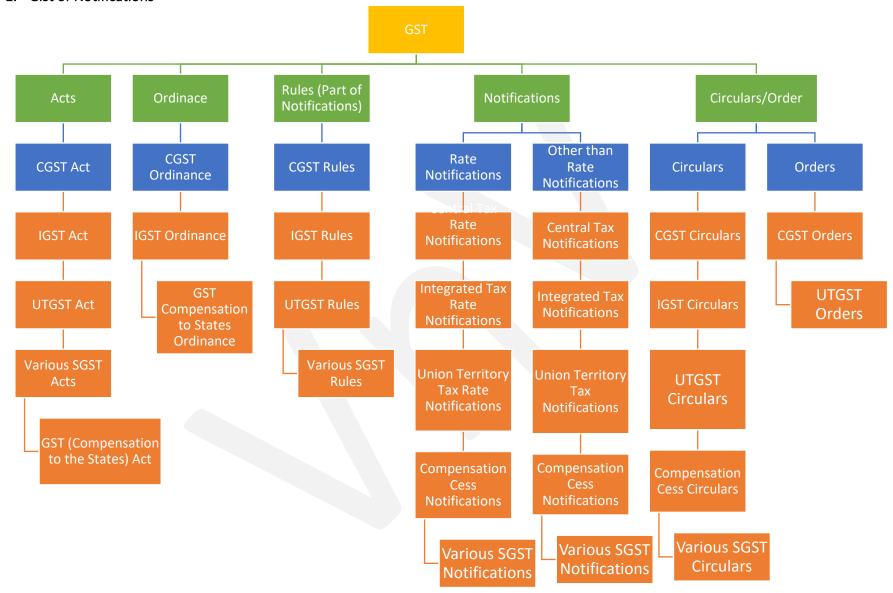

### Notes to Reader

#### 1. Gist of Notifications



Notification: Issued under the powers of GSTN Council as defined in the Act

Circular: Clarificatory in Nature; Order: Something that cannot be issued by way of Notification and needs amendment in the Act

### 2. Effective Date for the Notification

- a. Sec. 2(80) "notification" means a notification published in the Official Gazette and the expressions "notify" and "notified" shall be construed accordingly.
- b. Sec. 11(1) of the Central Goods & Services Tax ('CGST') Act, 2017 Government has power to grant exemption effective from such date as "may" be specified in the notification.
- c. Stating effective date in the Notification is **not mandatory**. Hence
  - i. If a particular date is specified in the Notification, changes made shall apply from such specified date.
  - ii. If there is NO effective date mentioned, it should be construed as effective from their publication.
